PFC INTERIM General Manager 2015-2016 GM LETTER

2016 and early 2017 have been times of great transition and change at our co-op.

Structural improvements to our floors and lighting. Improvements in our promotions and pricing with more and more staple grocery items at an everyday low price. And a continued commitment to improving every aspect of the customer experience at the People's Food Co-op!

Our/your staff has also collaborated to overcome challenges such as downed power lines and a basement flood and though it all we did our best to not have any interruption to our service and commitment to our members and shoppers.

Lesley Perkins, our General Manager of three and a half years stepped down in December. Her passion and caring for the co-op will always be remembered. Lori, our Wellness AND Customer Service Manager then stepped into the role of Interim GM, a job she has served our co-op in before. During her tenure this year she helped us through perhaps the greatest change of the past six months, the contract negotiation of our co-op as a unionized work place as our staff joined the local UFCW 876! To me, our staff unionizing is one step of many in our co-op's long journey to find a connective, supportive, conscientious and committed path forward towards food justice and on a larger scale, social justice.

We are more than a natural foods grocery store, kitchen, bakery and cafe. We are also stewards of change. But, we also are: a cafe, kitchen, grocery store and bakery. We do not exist in a vacuum and in the increasingly competitive food market of Ann Arbor we are challenged to maintain the differentiating and connective

he Co-op membership relies on its Board of Directors to keep cooper-

ative governance alive and well. There are Four Pillars of Cooperative Governance that shape the structure of PFC's business and our community. The Board shapes its work on these tenants: Teaming, Accountable Empowerment, Strategic Leadership and Democracy. As we conducted business this past year, we needed strategic leadership to determine how best PFC could meet its Ends Policies and achieve economic viability. As a cooperative we use the democratic process to practice and to promote our principles. It also means that PFC members have a great opportunity and responsibility to elect a Board of Directors to represent the members.

As members you count on your Board of Directors to keep cooperative governance alive and well. The Board is currently working on reestablishing our vision of community and our Ends Policies to determine how best to serve our Co-op in a fiscally sound manner. We are asking some hard questions: should we stay the size we are? Should we remain in downtown Ann Arbor or build a bigger store with a big parking lot somewhere else? How can we grow a younger and more diverse membership?


We welcomed three new members to the Board of Directors: Bruce Curtis, Persephone Hernandez-Vogt and Jaime Magiera. In the 2016 election, the membership voted to add 2 new directors to the Board. One will be added in the 2017 election,

and one in 2018, bringing the total number to 9 Directors. The Board meetings are held on the third Wednesday of each month at 6:30 p.m. at St. Andrews Church in Ann Arbor. All members are encouraged to attend.

This past year the Board was active in the following ways:

- We published Board and store information through our monthly newsletter, Board Matters.

- We held two retreats, one in October and one in March, to think through our mission and how to move forward with our commitments to the Co-operative.
- We undertook a complete reboot of our policies, reviewing them for accuracy and simplicity of interpretation.

Our General Manager, Leslie Perkins, resigned in mid-December 2016. Lori Crall, long term PFC staff member, served as the Interim GM until March 31. Angie Voiles, PFC Grocery Manager, is currently taking on the role of Interim GM. A search committee was formed in January 2017. It includes three Board members, three staff members, and one member at large. The Board hired Anne Evans, SPHR of Twenty 80, LLC to oversee the search. Our goal is to have a new GM in place by early Summer 2017.

PFC Board of Directors 2016-2017 TREASURER'S REPORT

2016 started out as a rough year for the co-op, as we lost over \$106,000 in 2015,

on sales of over \$6,471,000, a loss of about 1.6%. However, we were optimistic going into the new year, as we were working well together and our staff was providing consistent and timely financial reports. But we were also fighting a national trend of declining sales for food co-ops in markets with lots of natural foods competition, So we knew the Board, staff, and the General Manager had to be extra focused to get our financials turned around.

Changes were made in the store, with all new lighting and new floors. That really brightened things up. Also, early in the year, the discount structure was changed to bring us more into alignment with other co-ops around the country. Our membership discount structure was a legacy from the past that didn't seem to be rooted in any solid economics. In short, even though it was good for our members, it wasn't good for our co-op, as we were giving away too much money!

Over the course of the year, staff worked diligently to control costs in all departments, and a number of the departments reworked their product lines and improved their product layouts.

Our total sales over the summer were down, as many of our shoppers left town. Yet by the fall, we felt that we were still making progress. But then in November, we had the union organizing drive, which resulted in additional legal fees as we navigated through the organizing and union election process. We also had a rough day at the end of November, when we had to close the store on Wednesday, our member discount day, due to a sewer overflow in the basement, where we also lost inventory.

Then came the resignation of Lesley Perkins, our General Manager, which was a big blow late in the year. Yet, despite all this, we came out ahead of 2015, with a loss of \$78,600, an improvement of \$28,000. Our total sales for 2016

were up slightly over 2015. Our current forecast for 2017 indicates that we will be much closer to break-even at the end of this year.

As we close in on hiring our new General Manager, our task in front of us is to rapidly get the new GM up to speed, and working harmoniously with our dedicated staff members. Budgets and forecasts need to be reworked and long term plans need to be developed. We need to really strengthen our niche in the community, and we need to work closely with our members and staff to accomplish this. With your help, we can do this.

As Treasurer, I really appreciate the concerns I hear from our members and shoppers. We have a lot going for us, and I and the rest of the Board of Directors fully believe that we can turn this around, and make the co-op a viable prosperous enterprise for years to come.

Paul's life was shaped by his two great passions: community service and sustainable farming.


