



Café Verde provides a venue for local visual artists to showcase work in a community setting. We provide this opportunity to the general public, members and non-members alike. We offer the opportunity for a monthly rotation of visual art. We are located at 214 N. Fourth Ave, connected to our parent company, the People's Food Co-op grocery, of Ann Arbor, Michigan.

Café Verde offers vertical wall space to presenting artists. Our walls are primarily brick, with the exception of one section of drywall. Steel bars have been suspended against the walls as the means for hanging pieces. No other method for hanging is allowed. Measurements of the suspended bars are as follows: A) 20' 1", B) 10' 9", C) 6' and D) 4'. The space below the pole provides a minimum space of four feet. All artwork must be approved prior to hanging. Photographs, and CDs are acceptable forms of submission, or an appointment may be scheduled to view the art in person. No substitutions from the original lineup will be permitted without prior approval. All work must be in ready to hang. Artists are responsible for the proper hanging and removal of their work, as well as all equipment used.

Hanging will take place at a pre-arranged time. Removal of the show will also be at a pre-arranged time with management. Please remember that we have to take our patrons into account and make our best effort to be non-disruptive.

In spirit, the co-op supports all forms of artistic expression, although as a member-owned business we must consider the variation of our clientele. Therefore, art must be considerate to all members of the community. The determination of appropriateness will be decided entirely by PFC management.

Artists are encouraged to promote their show in the community by whatever means are seen to be fit by the artist. Café Verde and the PFC also offers mention on various media outlets. By entering into this agreement with the PFC of Ann Arbor, the artist gives permission to their artwork and personal picture(s) in promotion.

Café Verde asks for the following, to be displayed: 1) artist statement, 2) bio, 3) photo of themselves, 4) contact information for interested persons. We request this information to also be submitted digitally for promotional use. Artists are also encouraged to bring business cards, price information (if applicable), and title cards. **All sales are solely between the artist and buyer, without the café, cooperative, or any employees being involved in any manner.**

Although we will do our best to prevent an unfortunate event, the Peoples Food Co-op will not guarantee or take responsibility in any way for art that is lost, stolen, or damaged while on the premises. Art is shown and stored at the artist's risk. Potential hazards may include, but are not limited to: water damage, food or beverage spills, contact with customers, or any other related circumstances. By signing this, the artist agrees to release the Peoples Food Co-op of Ann Arbor for any possible liabilities arising from disagreeable matters, damage, customer relations, and any other potential financial, emotional, physical, or intellectual matters occurring during this showing.
